

During this holiday season and throughout the year, we, at Talquin, are privileged to work to power the communities we serve and empower our Members to improve the quality of their lives. One of the many ways we do this is by returning Capital Credits to you, our Members, who have invested over the years in your Cooperative.

Each year Talquin's Board of Trustees looks at the financial condition of the Cooperative to determine whether it is appropriate to refund Capital Credits (General Refund Checks) and, if so, the amount to be refunded. This year, your Board has authorized a Capital Credit refund of over \$3.1 million. Capital Credits will be distributed in the form of checks that will be mailed out this month.

Capital Credits are a reflection of the Cooperative which is owned by you, the Membership. We deliver service to Members at cost on a not-for-profit basis. Any margins (revenues in excess of costs) are allocated to Members during the year the margins are produced, and are later returned to those Members who received service during the year being refunded. The total amount of refunds to Talquin Members over the past seventy-four years is more than \$66.5 million!

It is through the combined efforts of you, our Members, the Talquin Board of Trustees, and Talquin employees that we were able to provide safe and reliable services throughout this past year. I thank you all for your support and wish you a Merry Christmas and a Happy New Year.

# **Holiday Closings**

The Wholesale Power Cost Adjustment (WPCA) will increase by 2.5 mills from 3.0 to 5.5 mills, effective January 1, 2015. Members who use 1,000 kWh per month will see an increase of \$2.50 in their monthly bill.

# Light Out? We Need to Know

If you see an outdoor light that is not working on Talquin Electric Cooperative's system, please call or email the Cooperative to report it. When reporting a problem, please provide the information listed below, so that we can make the repair and contact you if necessary.

- Provide the light number located on the pole and describe the location clearly. Information such as street name, nearest street intersection, or other landmarks are very helpful. Accurate information is very important in identifying the outdoor light, especially if there are multiple lights in the area.
- Describe the nature of the problem;

- such as light is blinking, bulb is burned out, etc.
- Provide contact information such as the name, address, email address, or phone number of the person reporting the outdoor light so that they can be contacted if needed.

Providing as much information as possible will help ensure the proper response for your request. We certainly appreciate your help in this matter. ## Stay Safe While You Deck the Halls

Festive lights give homes a magical glow both inside and out. When decorating this season, a few simple safety tips can keep your spirits bright.

- Do not overload electrical outlets. Most lights are designed to connect no more than three strands. Inspect the wires periodically to make sure they are intact and not warm to the touch.
- Never leave lights on overnight or when no one is home.
- Only use lights that have been approved by an independent testing laboratory.
- Replace any strands that show signs of damage, such as bare or frayed wires, broken bulbs, or loose connections. Faulty lights can send an electrical charge through a tree and electrocute anyone who comes in contact with a branch.

## **White Fruit Cake**

6 eggs

½ pound of butter (melt in microwave)

1 Cup sugar

1 pound candied cherries (cut in half)

1 pound candied pineapple (cut them up)

4 cups pecans (chopped or cut in half)

1 3/4 cups flour (plain is fine)

1 teaspoon salt

1 small bottle REAL vanilla extract (use it all)

1 small bottle lemon extract (use it all)

Oil and flour a tube or Bundt pan Mix all ingredients together after following directions for each. Put in the pan and bake at 225° to 250° for 1 hour 40 minutes to 2 hours 30 minutes depending on your oven. Check periodically and when firm, remove from oven.

This is called a White Fruitcake because it uses no citron, raisins, or other things that make it dark and has a better flavor than the ones with those ingredients that some people don't like such as citron. I believe the vanilla and lemon extract add greatly to the flavor.

\*You may want to make small fruitcakes to give for Christmas but I don't know the length of time you would bake them.

1 cup packed brown sugar

1 cup pecans, chopped

<sup>2</sup>/<sub>3</sub> cup melted butter

½ cup flour

2 eggs, beaten

1 tsp. vanilla

Combine sugar, flour, pecans, and mix well. Combine butter, eggs, mix everything well. Grease pan.

Bake 350 degrees for 15-20 minutes in small muffin pans.
