# What is the True Cost of a Storm?

Though Talquin's emergency power restoration efforts following Hurricane Michael were completed in October, the full recovery process will take many more months, if not longer, to complete. Below are a couple of updates on items that Talquin is still working through:

### • Clean Up – Broken Poles/Damaged Materials:

As crews restored power, they left old material (broken poles, crossarms, insulators, etc.) at the base of the poles where the damage occurred. Our crews left this material to be cleaned up later in order to speed up the restoration process. Please know this will take time due to the fact that we have approximately 20,000 pole locations that have material needing to be cleaned up over our 4,400 miles of power lines. We have contracted with MasTec to assist with this process. Crews started in Gadsden and Liberty counties (our hardest hit areas) in December, and their target completion date is by the end of January.

• **Trees & Limbs Near Lines:** Hanging limbs and leaning trees continue to threaten power lines and cause outages throughout Talquin's system. Talquin has contract crews that will be assessing the lines and will be removing these trees/limbs. We have contracted with Davey Tree Expert Co. to assist with this process. Crews will start in Gadsden and Liberty counties the first week in January, and their target completion date is early April.

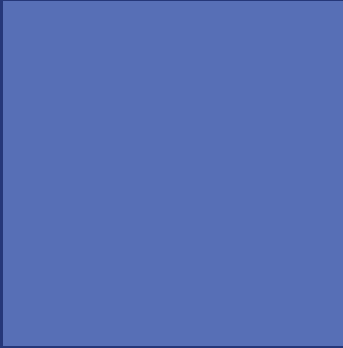
• **Outdoor Light Repairs:** While Talquin has already repaired 242 outdoor lights as of mid-December, we still currently have over 700 service orders for outdoor lights that need to be repaired. Please be patient and know that Talquin will get to these lights as quickly as possible, but it will take some time. Talquin is providing monthly bill credits to affected accounts. - **Financial Impact:** In addition to the physical work still being done, Talquin is also working through the financial impacts from the storm restoration efforts. The total financial impact to Talquin caused by Hurricane Michael will total \$35 to \$40 million. From \$3,000,000 in materials and \$260,000 in fuel, to over \$11,000,000 in labor (Talquin went from a company of less than 200 employees to a total work force of over 800 people during restoration!), all of these items really added up. Though the Federal Emergency Management Agency (FEMA) will reimburse Talquin up to 75% of the total expense (this still leaves Talquin with \$9 to \$10 million of unreimbursed expense), the reimbursement process can take up to two years or longer. Talquin is still waiting on expense reimbursements for Hurricane Irma from back in September 2017. In order to have enough cash to pay expenses associated with Hurricane Michael, Talquin had to borrow money. Even though the co-op has access to low interest loans, Talquin will pay around \$1 million annually in interest.

All of these items will take time, and Talquin appreciates everyone's patience and understanding as we all work through the recovery process together.

## Congratulations to Debra Sansom on retiring after 40 years of service at Talquin!

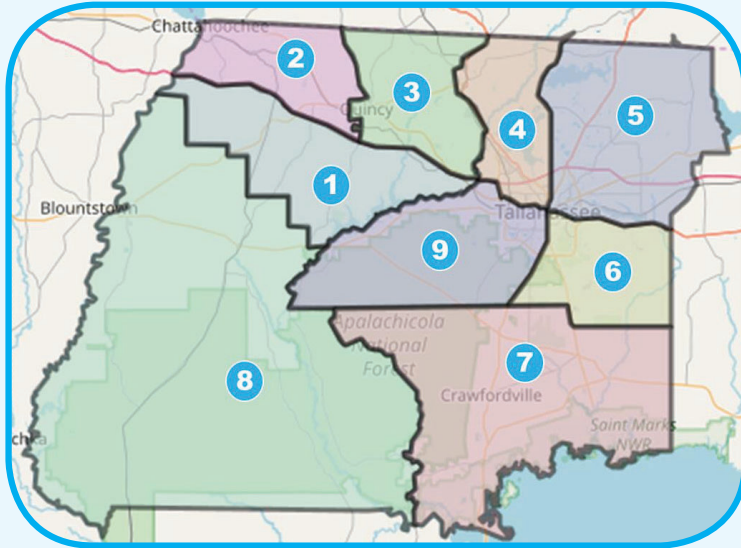

## BYLAWS PROVIDE GUIDANCE FOR ANNUAL MEETING AND TRUSTEE SELECTION

### ARTICLE III

#### Meetings of Members

**SECTION 1. ANNUAL MEETING.** The Annual Meeting of the members shall be held once each calendar year at a time and place in the service area of the Cooperative as shall be selected by the Board of Trustees and designated in the notice of the meeting, for the purpose of electing Trustees, passing upon reports for fiscal year and transacting such other business as may come before the meeting.

**SECTION 5. VOTING.** Each member shall be entitled to only one vote. All questions shall be decided by a vote of a majority of the members voting thereon in person, except as otherwise provided by law, the Articles of Incorporation or these By-laws. No voting by mail or by proxy shall be permitted.

### ARTICLE IV

#### Trustees

#### SECTION 2. QUALIFICATIONS AND TENURE.

To become or remain a Trustee, a person must meet the qualifications listed in the By-laws approved and amended effective April 29, 2017.

#### SECTION 3. NOMINATION AND ELECTION OF TRUSTEES

(b) **Nominations.** Nominations for trustee shall be by Petition only. To be nominated and included on the ballot to represent one of the nine (9) geographic districts, a candidate for trustee must submit to the Talquin Electric Cooperative Headquarters located at 1640 West Jefferson Street, Quincy, Florida 32351 a written Petition including the names, addresses, and verifiable signatures of at least fifteen (15) current Cooperative mem-

bers. All Petitions must be submitted to the Talquin Electric Cooperative Headquarters prior to the deadline prescribed below and shall include the name of the nominee and his or her district. A member may sign the Petition of more than one candidate.

To be considered for inclusion on the ballot, Petitions must be submitted to Talquin Electric Cooperative Headquarters, located at 1640 West Jefferson Street, Quincy, Florida 32351 by 5:00 P.M. E.S.T. not less than forty-five (45) days, but not more than ninety (90) days before the date of the Annual Meeting. A Cooperative designee with the assistance of the Cooperative's attorney shall verify the signatures on the Petitions and refer the names of those candidates who have satisfied the fifteen (15) signature requirement for qualification review in accordance with Article IV, Section 2.

Not less than thirty (30) days prior to the date of the Annual Meeting, the Secretary shall post the names of the qualified nominees for election at the Talquin Electric Cooperative Headquarters, located at 1640 West Jefferson Street, Quincy, Florida 32351. The Secretary shall mail with the Annual Meeting Notice a complete list of the names and addresses of all qualified nominees for election.

If any of the dates for compliance specified in this Article shall fall on a Saturday or Sunday or legal holiday, then the next business day following the Saturday, Sunday or legal holiday shall be the day of compliance. All dates for compliance specified in this Article shall be posted on the Cooperative's website at least ninety (90) days before the deadline.

# Democratic Member Control

There are many things that set electric cooperatives apart from other types of utilities. One of the most unique differences is that co-ops are not owned by shareholders but by the communities they serve. Each Member of Talquin has a voice and a vote in how their cooperative is operated and governed.

The Annual Meeting hosted by Talquin is just one example of how Members can participate in the operation of their cooperative. Members can vote on by-laws, elect representatives to Talquin's Board of Trustees, and voice their opinions directly to the Board of Trustees.

Those elected to serve on the Board are also Members who live and work in our community, and they have an obligation to govern the cooperative in the most effective and efficient way possible. Talquin's General Manager, Tracy Bensley, is selected by the Board and is ultimately responsible to each and every Member.

Select trustees also serve on the Board of Seminole Electric Cooperative (Seminole), Talquin's wholesale power provider, to ensure that Talquin continues to receive the most safe, reliable, and affordable electricity for our Members. Tracy Bensley, Carrie Durden, and Sam Fenn currently sit on Seminole's Board to represent Talquin. Similar to the way Talquin's Board of Trustees governs issues that affect our co-op, the Seminole Board of Trustees oversees issues and topics affecting Seminole and its Members.

Talquin is committed to education and training so that each Member understands how the electric cooperative operates and how to exercise their vote as an owner. The Board and staff at Talquin are responsible to you, our Members, in each and every aspect of how safe, reliable, and affordable utilities are provided to you.

## Coming Soon! Crawfordville Operations Center



We are happy to announce that we are still on target for opening Talquin's new Crawfordville Operations Center in March of 2019. The 14,800 sq foot facility is located adjacent to the Crawfordville Member Service Office and will be the new home of the operations personnel that currently report to our south Tallahassee location on Crossway Road. The new center will assist Talquin with more efficient operations and help improve reliability for the expanding utility systems in the Wakulla County service territory.





# Notify County Agency of Any Special Needs

*Registry is used for resource planning during emergencies*

According to Chapter 252.355 Florida Statutes, "In order to meet the special needs of persons who would need assistance during evacuations and sheltering because of physical, mental or sensory disabilities, each local emergency management agency in the state shall maintain a registry of persons with special needs located within the jurisdiction of the local agency."

The Special Needs Registry Shelter Program is designed to provide hurricane or disaster related evacuation assistance and care for those without other alternatives. Anyone that needs transportation assistance or has a health/medical condition that requires medical attention while at a shelter should register for this program. Clients of a hospice or home health care agency should ensure that they have already registered into the system. This registration helps the local emergency management agency identify those in need of assistance and plan for resource allocation to meet those needs.

Persons with special needs may authorize emergency response personnel to enter their homes during search-and-rescue operations, if necessary, to ensure their safety and welfare following disasters.

This registration must be updated annually. Talquin Electric Cooperative helps local emergency management agencies get the word out about this program.

If someone has a special condition affecting eyesight, hearing, speech, walking, breathing or an emotional condition and would need assistance during evacuations and sheltering, they should contact their local emergency management agency.

The level of care given in special needs shelters goes above the basic first-aid care available to shelters open to the general population.

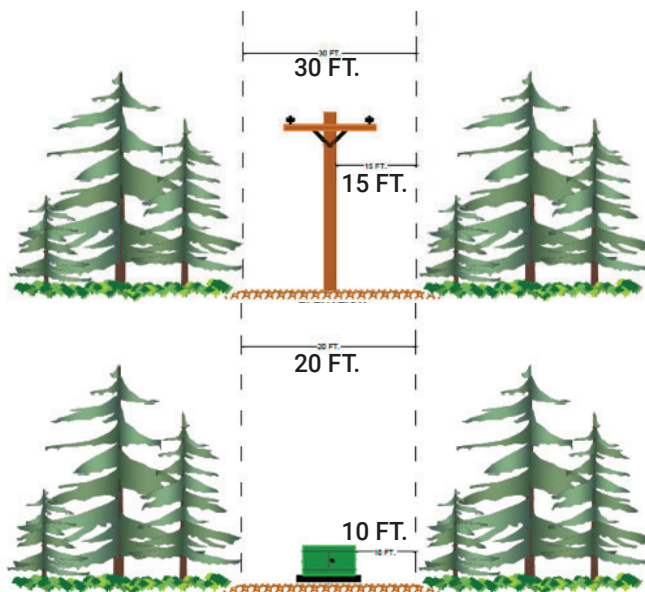

## **Florida Broccoli & Avocado Soup**

### **Ingredients:**

1 cup Florida broccoli, chopped  
1 cup fresh Florida spinach  
1/2 Florida avocado  
1 tablespoon olive oil  
1 onion, chopped  
2 cloves fresh garlic, minced  
1/3 cup low-fat milk  
1 1/4 cup low-sodium vegetable broth  
1 cup homemade croutons  
4 teaspoons parmesan cheese, grated  
Sea salt and fresh ground pepper, to taste



1. Place a medium-sized stockpot over medium-high heat.
2. Add 1 tablespoon of olive oil to the preheated pan. Add onion and garlic to the pan and sauté until translucent.
3. Add broccoli, vegetable broth and milk to the pan. Reduce heat and bring to a simmer. Cook ingredients until the broccoli is just crisp-tender.
4. Add broccoli mixture to a blender with a tight-fitting lid. Make sure not to fill the blender more than half full at a time. Add the avocado and spinach to the blender as well. Carefully pulse the ingredients until smooth and creamy.
5. Taste soup and adjust seasoning with salt and pepper. Return soup to pot and heat back up to serving temperature. Garnish soup with croutons and parmesan cheese.

## Chicken Broccoli Casserole

### Ingredients:

Nonstick cooking spray or butter, for the baking dish  
 4 boneless, skinless chicken breasts  
 Kosher salt and freshly ground black pepper  
 1 medium head broccoli, cut into small florets  
 2 cups cooked white rice  
 1 10-ounce can condensed cream of chicken soup  
 1 cup sour cream  
 1/2 cup mayonnaise  
 1 tablespoon lemon juice  
 10 ounces cheddar, grated (about 2 1/2 cups)



1. Preheat the oven to 350 degrees. Grease a 9x13x2-inch baking dish with nonstick cooking spray or butter.
2. Place the chicken in a large pot with water to cover. Add some salt, bring to a boil, then reduce the heat to a low simmer and cook the chicken until tender, about 45 minutes. Drain the chicken, cover, and refrigerate until cool, or up to 24 hours. Shred.
3. Meanwhile, bring a medium pot of generously salted water to a boil. Add the broccoli florets, and boil until crisp-tender, 2 to 3 minutes.
4. Spread the rice in an even layer in the baking dish. Make a second layer with the broccoli. In a large bowl, mix the chicken soup, the sour cream, mayonnaise, lemon juice, shredded chicken, half the cheddar and some salt and pepper. Pour the mixture over the broccoli and top with the remaining cheddar. Bake for 40 minutes; let stand for 5 minutes before serving.

## Parmesan-Roasted Cauliflower

### Ingredients:

1 large head cauliflower  
 3 tablespoons good olive oil  
 Kosher salt and freshly ground black pepper  
 1 cup freshly grated parmesan cheese (2 ounces)  
 1 cup freshly grated gruyere cheese (2 ounces)



1. Preheat the oven to 350 degrees.
2. Remove the outer green leaves from the cauliflower and cut the head into florets, discarding the stems. Place the florets on a sheet pan. Drizzle with olive oil and sprinkle generously with salt and pepper. Toss well. Bake for 30 minutes, tossing once, until the cauliflower is tender and starts to brown. Sprinkle with the parmesan and gruyere and bake for 1 to 2 more minutes, just until the cheese melts. Season to taste and serve hot or warm.

## Cauliflower Fritters

### Ingredients:

6 cups cauliflower  
 1/2 cup all-purpose flour  
 3 extra-large eggs  
 1 teaspoon baking powder  
 1 (.7 ounce) package dry Italian-style salad dressing mix  
 1/2 cup olive oil for frying, or as needed



1. Process cauliflower in a food processor finely minced; transfer to a large bowl.
2. Stir flour, eggs, baking powder, and Italian dressing mix into cauliflower.
3. Heat enough olive oil to cover the bottom of a frying pan over medium heat.
4. Drop heaping tablespoons of cauliflower mixture into the hot oil; fry until golden brown, about 3 minutes per side.

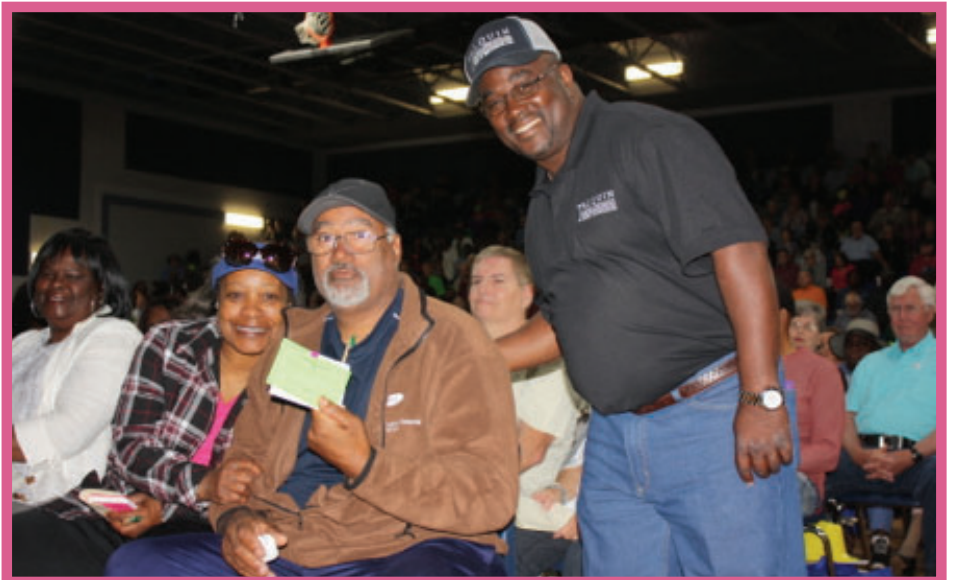
