Manager's Column

Current diversion, also known as power theft, is the criminal practice of stealing power. Theft of power services is not just illegal – it is dangerous and can have fatal consequences!

Power theft creates a safety hazard for the public and Talquin Electric employees. There is no safe way to steal power. Over the years, we have seen some very creative ways in which Members have diverted power or damaged meters, resulting in inaccurate readings.

On average, we encounter 26 power diversions each year. Talquin always works with law enforcement to ensure thieves are held responsible for their criminal actions. Under Section 812.14 of the Florida Statutes, someone convicted of power theft can be fined \$1,000 or up to three times the cost of the electricity stolen. They can also face up to one year in prison and/or probation.

Theft of electricity is not a victimless crime. The cost of the stolen power and any necessary repairs to damaged equipment is absorbed by the Cooperative. Therefore, our Members pay for the stolen electricity. The theft of electricity affects all of Talquin's Members. When someone steals electricity, they are really stealing from their fellow Members – neighbors, family, and friends.

Talquin works hard to minimize the impact of theft on our Members. In addition to our servicemen that regularly service meters, digital meters have been installed throughout our service territory. These advanced meters have the ability to detect tampering and alert personnel. Each meter has been outfitted with a warning label that discloses this information.

As a Member, if you suspect someone is stealing power, you can report it anonymously on our website or by calling 850-627-7651.

Honor Flight

If you have heard about Honor Flight, you know what an amazing program it is. If you have not, you need to learn more. Honor Flight Tallahassee was established in 2012 to bring the program to the North Florida and South Georgia area. This program's mission is to take veterans to Washington, D.C., to visit memorials dedicated to honor their service and sacrifices, all at no cost to the veteran! Priority is given to heroes with the most seniority, survivors of WWII, and any veteran with a terminal illness who wishes to visit their memorial.

On May 20th, we had the honor and privilege of attending the celebration of these heroes before they boarded their early morning flight and when they got home. One of those heroes was OUR Member, John Sullivan. Mr. Sullivan could not understand why he was being treated like royalty, and we simply stated "Because to us...you are." Not all of these veterans received a proper welcome when they returned home from serving their country, but on the day of the Honor Flight, they were shown appreciation and gratitude from everyone in attendance. In the event my monthly account(s) display(s) a credit, then the credit due will be rounded down to the nearest dollar, and the funds retained will be donated to TAP. I understand that the funds I donate each month will be used by Talquin for charitable purposes which will primarily focus on assisting other Talquin Members who cannot pay their utility bill. I understand that, should the total amount of donations exceed this charitable purpose, the excess donations may be used for such other charitable purposes as are approved by the Board and reported to the Membership.

I understand that participation in TAP is voluntary. I also understand that this is an on-going agreement, and that I must notify Talquin Electric Cooperative if I choose to discontinue my participation in this voluntary program, and that the processing of a termination request may take up to thirty days. I also understand that any donations I make to TAP are non-refundable.

I understand that Talquin may utilize third party agencies (for example, Capital Area Community Action, and/or Salvation Army) to handle disbursements of TAP funds to Members. Members who seek assistance under TAP may be referred to these third party agencies for screening, and any person so referred will be screened on the basis of that agency's criteria. Members seeking assistance will not be required to be contributing to TAP.

I understand that contributions to this program are not tax deductible, and that Talquin will not publish the names of Members who contribute; however, overall program statistics and benefits of the program may be reported to the Membership at least annually.

Wholesale **Power Cost** Adjustment Increase

Effective August 1, 2017, **Talquin Electric Cooperative** will adjust the Wholesale Power Cost rate from a credit of -\$0.0060 to a credit of -\$0.0030 resulting in an overall increase of 3 mills. Members who use 1,000 kWh per month will see an increase of \$3.00 in their monthly bill. Water and wastewater rates will not be affected by the WPCA change.

Member of the Month

Fourth of July, America's Independence Day, is celebrated by Americans around the world each year. We celebrate and remember those who fought and died to free our country. We celebrate to honor those heroes who have continued to fight for our freedom for over two hundred years. One of those heroes is Talquin Member John Sullivan. Mr. Sullivan is an American that exemplifies what our great nation is all about – diversity and integrity. Born in Brooklyn, New York, after his pregnant mother and father moved to the United States from Ireland; Mr. Sullivan was raised in Spanish Harlem. He attended Catholic school, boxed from age six with the Police Athletic League, and grew up on the streets of New York. At the early age of 15, Mr. Sullivan ran off to the United States Maritime Service, which later led to a 20 year career in the United States Navy. The majority of those years were spent with the Marines, where he served with the medevac unit as a Hospital Corpsman Chief Petty Officer. During this time, Mr. Sullivan earned the Bronze Star and three Purple Hearts in Vietnam. His



Vietnam veteran status earned him a seat on the Tallahassee Honor Flight last month, which is where we met and were able to get to know Mr. Sullivan. We are honored that he is OUR Member, and we are thankful for Mr. Sullivan and all the other veterans who have served our country!

Red, White and Blue Bruschetta

- 1 loaf Italian bread
- 1 1/2 cup grape tomatoes chopped in half
- 3/4 cup blueberries
- 1 tsp olive oil, plus 1/4 cup
- 3/4 cup feta cheese, crumbled
- 1 clove garlic
- black pepper to taste

Preheat oven to broil.

Slice bread into 1/2 inch thick slices. Lightly brush both sides of the slices of bread with olive oil. Place on a baking sheet and bake for 7 to 10 mins or until golden brown. Remove from oven and rub one side of bread with garlic. Allow to cool before topping.



Mix tomatoes, blueberries, 1 tsp olive oil, feta cheese and black pepper together in a bowl. Place a spoonful onto each slice and enjoy!
