

# Powering Our Community for 85 years – Safely, Affordably, & Reliably

Tracy Bensley General Manager For 85 years, Talquin has stayed true to its mission: to provide **SAFE**, **AFFORDABLE**, and **RELIABLE** utility services to Memberowners. Thanks to the dedication of Talquin's Trustees, employees, and engaged Member-owners, that mission continues to thrive across the services Talquin provides.

## How does Talquin ensure its services are provided SAFELY?

Safety is at the core of everything we do. Our teams undergo regular emergency response plan training and uphold a strong cybersecurity framework to protect critical systems and data. Talquin also invests in replacing aging infrastructure and vegetation management to reduce electric hazards. From safety education to internal planning and training and our commitment to clean energy, we are committed to protecting Member-owners, employees, and the environment.

In addition to electric services, Talquin operates extensive water and wastewater infrastructure across the four counties we serve. Our six wastewater treatment plants process approximately one million gallons of effluent daily, protecting communities from exposure to raw sewage and safeguarding groundwater. We also deliver about 6 million gallons of clean,

safe drinking water each day to more than 27,000 services—helping to protect public health and ensure reliable access to safe water.

#### What does Talquin do to help keep utility rates AFFORDABLE?

Affordability has been part of our DNA from the beginning. In1957, Talquin began purchasing low-cost energy from the Jim Woodruff Dam—saving Member-owners about \$2 million annually. In 2023, Talquin invested in solar energy, and that investment has already led to a \$340,000 savings for Member-owners in 2024 alone.

We also empower Member-owners to save with tools to help make your bills more affordable. These tools include our Smart Thermostat Program, with savings through bill credits; Energy Audits for a no-cost review of usage and facilities; usage monitoring via the Talquin Website and Mobile App, empowering you with tools for better energy management; and Levelized Billing, a 13 month rolling average that removes the seasonal ups and downs of your electric bills.

## How does Talquin provide RELIABLE utility services?

Reliable service means keeping the lights on and water flowing—no matter what. That's why we maintain and upgrade infrastructure, manage vegetation, and build system redundancies like back-feeds for faster restoration.

We also advocate at the state and federal levels to ensure legislation and regulation supports rather than hinders reliability for the electric, water, and wastewater services we provide.

At Talquin, providing Member-owners with **safe**, **affordable**, and **reliable** utility services is not just a goal; it is our mission and at the heart of everything we do.

### **District 8 Clifford Bristol, Vice President**







## District 9 Kelly Wiley

# **YOUR VOICE MATTERS: HIGHLIGHTS FROM THE 2024 MEMBER SURVEY**





# Meet The Department:

Meet the Talquin Water & Wastewater Department! This Department ensures Talquin's water and wastewater systems are safe, dependable, efficient, and sustainable.

This team works hard behind the scenes so that that when you turn on the tap, clean, safe water is available. From building and maintaining water mains, performing daily water quality tests, to staying in full compliance with the Department of Environmental Protection quidelines, this team is always on the move. Leading these efforts is John Hallas, Ph.D., who serves as the Department's head. Dr. Hallas oversees 25 water systems, 46 well sites, and six wastewater treatment facilities with an extensive network of more than 900 miles of pipeline.

# Keeping the Water Flowing: Construction and Maintenance

The Department's Construction and Maintenance team is key to keeping the water system running smoothly and efficiently. This dedicated group is always hard at work, managing the complex network of pipes, valves, and infrastructure that delivers water to homes and businesses. From guickly responding to water main breaks to flushing the system to maintain water quality, their efforts are crucial in ensuring Talquin's water operations flow seamlessly. They also play a vital role in building new infrastructure to support the growing needs of Talquin Members. Whether they are out in the field or addressing service issues, this team is always ready to take action. Leading the way is Dewey O'Conner, with a skilled six person crew, all of whom are dedicated to keeping the system running smoothly and efficiently.

The Water Operations team is essential to the seamless delivery of drinking water and effective functioning of the wastewater treatment plants. They are also tasked with maintaining critical systems, conducting regular testing of water and wastewater to ensure compliance with standards, and overseeing the daily operations of the plants. The team also includes in-house electricians who provide immediate support to troubleshoot and restore vital systems, as needed. Leading the Operations team is Gary Wallace, who guides a skilled team of 16. Together, they ensure the reliability and safety of Talquin's water and wastewater services.

The Department's in-house team is crucial to supporting field personnel and maintaining the integrity of Talguin's vital water and wastewater systems. Jacqueline Noyes plays an essential role in overseeing waterrelated projects, including new services, backflow prevention, and contract management. Kevin Goff ensures that development and construction projects meet Talquin's high standards. Out in the field, Andrew Clark serves as the inspector, making sure those standards are consistently met every step of the way. Rob Driver is responsible for conducting bacteriological testing, confirming that our drinking water remains safe and clean. Meanwhile, Chris Colson handles regulatory compliance, offering key support to both the Construction and Operations teams and ensuring everything runs smoothly.

# Be in the Know about Backflow!

Talquin is responsible for maintaining a Cross Connection Control Program as required by the Florida Department of Environmental Protection (FDEP) and the Federal Government's 1974 Safe Drinking Water Act. Talquin water service Members are responsible for having your backflow preventer tested and, if necessary, repaired. Backflow testing can reveal malfunctions or leaks. A leaking backflow preventer will add usage to monthly meter readings.

What is Backflow Testing? Backflow testing is a vital procedure aimed at safeguarding the integrity of our water supply system. It involves the inspection and assessment of backflow prevention devices. These devices ensure that water flows in one direction only, preventing any potential contamination from entering clean water supply.



Why is Backflow Testing Necessary? Regular backflow testing helps ensure that our water supply system meets the highest standards of safety and reliability. By identifying and addressing any issues with backflow prevention devices, we can mitigate the risk of contamination and uphold the quality of water delivered to your homes and businesses.

# What do Members Need to Know?

- Check the mail! Backflow letters were mailed in April.
- The device is commonly located at your property line adjacent to your water meter above the ground.

# Ingredients:

3 tablespoons salsa verde	8 blue corn tortilla chips,	1000
1 tablespoon plus 1 teaspoon extra-virgin	broken into large pieces	*****
olive oil, divided	1/2 cup canned red kidney beans	
2 tablespoons chopped cilantro	1/4 avocado, sliced	
2 cups salad greens	1 large egg	Sector 14

# Instructions:

- 1. Whisk salsa, 1 tablespoon oil, and cilantro in a small bowl. Toss half the mixture with salad greens in a shallow dinner bowl.
- 2. Layer chips, beans, and avocado atop the salad.
- 3. Heat the remaining 1 teaspoon oil in a small nonstick skillet over medium-high heat. Add egg and fry until the white is completely cooked but the yolk is still slightly runny, about 2 minutes.
- 4. Serve the egg on the salad. Drizzle with the remaining salsa vinaigrette and sprinkle with additional cilantro, if desired.

# **Storm Cost Recovery Surcharge**

Effective June 1, 2025, a Storm Cost Recovery Surcharge (SCRS) will be added to electric bills. This charge recovers \$8 million of non-reimbursed expenses resulting from severe weather events, including Hurricane Debby, Hurricane Helene, Winter Storm Finn, and Winter Storm Enzo. Thank you for your understanding and support as we rebuild our system together. For Residential Service (RS) rate accounts, the estimated monthly impact will be \$9.42 for 1,000 kWh. The SCRS will be in effect for twelve months (12).



# **Notice: WPCA Adjustment**

Effective June 1, 2025, Talquin Electric will increase the Wholesale Power Cost Adjustment (WPCA) from \$.0020 to \$.0045, resulting in an overall increase of \$2.50 per 1,000 kWh. This change does not impact water and wastewater charges.

In April, Talquin held its Annual Storm Response Training to ensure our team is ready to respond safely and quickly when severe weather strikes. The training focused on outage management, safety procedures, communication strategies, and our emergency response plan.

A key part of the training highlighted the importance of documenting storm restoration efforts for the Federal Emergency Management Agency and the Florida Department of Emergency Management to

qualify for the most reimbursement available. Storms and restoration cost a lot of money.

We believe in preparing for gray skies on blue sky days. That mindset ensures we are fully equipped to support Members and communities, no matter what the forecast holds.
