Talquin Electric Awards Scholarships to Youth Tour Students

Twenty-four high school juniors from Gadsden, Leon, Liberty, and Wakulla Counties participated in the 2021 Talquin Electric Cooperative Youth Tour. Each student who participated received a \$2,500 or \$500 scholarship for college or post-secondary education. Talquin selected students from its membership to participate in the Youth Tour based on academics, leadership, communication skills, and volunteer service in their schools and communities.

Although the COVID-19 pandemic led to the cancellation of the traditional Tallahassee Youth Tour, Talquin's leadership decided to host a scaled-down version of the Youth Tour at Talquin's facilities. In addition to visiting Talquin sites, such as a substation, water tower, and wastewater treatment facility, Talquin's student representatives met with State Senator Loranne Ausley and State Representative Jason Shoaf to discuss the issues affecting the students and educate the

students about the importance of using their voice to shape our democracy.

From this outstanding group of leaders, Talquin selected six students to receive a \$2,500 scholarship to go towards college or post-secondary education. Talquin typically selects four delegates and two alternates to represent Talquin at the Washington D.C. Youth Tour in June, but the National Rural Electric Cooperative Association (NRECA) cancelled the event due to the pandemic. 


In Memory of Sharon Bentley (1946-2021)

Ingredients:

2 pounds fresh potatoes, sliced ¹/₄-inch thick (little, thin-skinned potatoes work best here) 2 tablespoons of sea salt 2 large garlic cloves

Dijon Vinaigrette:

1 tablespoon Dijon mustard

1/4 cup champagne vinegar or white wine vinegar

1/3 cup olive oil

1/4 teaspoon black pepper

Instructions:

- 1. Boil the Potatoes: Place the sliced potatoes in a large saucepan cover completely with cold water. Sprinkle in salt and bring to a boil. Add the 2 cloves of garlic, reduce heat, and simmer 5 minutes or until potatoes are just tender.
- 2. Make the Vinaigrette: While potatoes are simmering, make the vinaigrette by whisking together Dijon, oil, vinegar, and pepper in a small bowl. Set aside.
- 3. Assemble: Drain potatoes and garlic. Place potatoes in a mostly single layer on a baking sheet to cool. Mince the cooked garlic and add to the vinaigrette. Drizzle the vinaigrette evenly over the warm potatoes. Let sit at room temperature for about 10-15 minutes.
- Serve: Add to a serving bowl gently tossing with the chopped 4. fresh herbs. Serve at room temperature or refrigerate and chill.


- 1. Place 1 cup guinoa in a medium pot with 1 and 1/2 cups water and a pinch of salt. Bring to a boil, cover, simmer on low heat 12 minutes (or until water is gone). Turn heat off, let stand 5 minutes, then let cool uncovered.
- 2. While the quinoa is cooking, make the raw apple cider vinaigrette. Place all ingredients in a small bowl and whisk, or in a small jar, sealed with a lid and shaken.
- З. Place carrots, celery, scallions, cilantro, garlic, and almonds in a large bowl. Toss with the vinaigrette and the cooled guinoa. Add more salt, pepper, and vinegar to taste. Sprinkle in the cayenne and optional allspice.
- 4. Toss well and serve or refrigerate until serving.

When it comes to lightning, go by the 30/30 rule:


- If 30 seconds or less from "flash to bang" seek shelter
