RATE SCHEDULE S - SEWER

AVAILABILITY:

Available to members of the Cooperative in those areas where sewer service has been established.

APPLICABLE:

To any member for residential and small commercial uses.

LIMITATION OF SERVICE:

Resale service not permitted hereunder. Service is subject to the Cooperative's current effective rules and regulations and limited to members whose usage does not exceed 100,000 gallons per month.

RATE:

MINIMUM MONTHLY CHARGE:

The minimum monthly charge shall be the Facilities Charge regardless of the amount of water used.

TERMS OF PAYMENT:

The above rates are net, with gross rates being 10% higher not to exceed net plus \$5.00. In the event the current monthly bill is not paid within ten (10) days from the date of the bill, the gross rates shall apply. Bills rendered hereunder are payable within the time limit specified on the bill and at Cooperative designated locations.

ADJUSTMENTS:

All charges under this rate are subject to the Cooperative's current effective billing adjustments including any applicable taxes, assessments, fees, and/or surcharges legally imposed by any governmental authority and may be increased or decreased without prior notification.

EFFECTIVE DATE: With billing commencing November 1, 2020.

RATE SCHEDULE - SEWER
SPECIAL PROVISIONS

USAGE OVER 100,000 GALLONS PER MONTH:

The Cooperative may refuse sewer service to connections whose monthly usage exceeds 100,000 gallons per month when service to such an account would limit the ability of the Cooperative to fulfill its other service commitments. The Cooperative may also implement special rates that recognize demand when accounts using over 100,000 gallons per month are serviced. The Cooperative may refuse to accept for treatment or require pretreatment of any wastewater it deems potentially harmful to its collection and/or treatment facilities.

SERVICE CHARGES: (System Fee plus Connection Fee)

0.75 inch meter or smaller	\$ 4,500	The Connection Fee for all meter sizes shall be the greater of A) \$600 or B) Cost to construct, connect and meter sewer service lateral.

4 inch meter	\$ 112,500

8 inch meter	\$ 360,000	When required, main line extension construction costs shall be paid as part of the Connection Fee.

SYSTEM FEE:

System Fee applicable when adequate treatment and/or system capacity available. If adequate treatment and/or system capacity not in place, applicant required to pay contribution in aid of construction to provide required treatment and/or system capacity.

MULTI-UNIT APPLICATION:

Service charges are determined by multiplying the total number of units times the applicable System and Connection Fees.

EFFECTIVE DATE: With billing commencing January 1, 2006.
