### SEPTEMBER IS NATIONAL PREPAREDNESS MONTH!

Although we are barely halfway through the 2021 Atlantic hurricane season, we have already seen eight named storms so far, including Tropical Storm Fred who paid our service territory a visit last month. September is National Preparedness Month, and there is no better time than now to prepare for hurricane season.

Tropical Storm Fred served as a reminder to us all that forecasts can change in the blink of an eye. Going into the weekend, Fred looked to be heading west towards Louisiana, but by Monday morning, Fred was headed our way. While we have weathered much larger storms such as Michael, Tropical Storm Fred left its mark on our rural communities.

With the help of mutual aid crews from Choctawhatchee Electric Cooperative (CHELCO), Tri-County Electric Cooperative, and Pike Energy, we restored nearly 10,000 meters in less than 36 hours! Thanks to Talquin's extensive storm training and preparation, we were able to have an efficient restoration process.

Each year, Talquin personnel participate in pre-storm briefings—reviewing the best practices and safety protocols to apply before, during, and after a storm. These employees complete a series of trainings and pre-storm drills in which they respond to hypothetical situations so they know what to do when faced with the same situation in real life.

Although it is Talquin's responsibility to restore power and water services after a storm, you, your family, and your community can take a few steps each week in September to ensure you are prepared for a disaster too. Please visit ready gov for more information.



#### Week 1 September 1-4: Make A Plan

Talk to your friends and family about how you will communicate before, during, and after a disaster. Make sure to update your plan based on the Centers for Disease Control recommendations due to the coronavirus.



#### Week 2 September 5-11: Build A Kit

Gather supplies that will last for several days after a disaster for everyone living in your home. Don't forget to consider the unique needs each person or pet may have in case you have to evacuate quickly. Update your kits and supplies based on recommendations by the Centers for Disease Control.



#### Week 3 September 12-18: Low-Cost, No-Cost Preparedness

Limit the impacts that disasters have on you and your family. Know the risk of disasters in your area. Learn how to make your home stronger in the face of storms and other common hazards. Check your insurance coverage to make sure it is up-to-date.



#### Week 4 September 19-25: Teach Youth About Preparedness

Talk to your kids about preparing for emergencies and what to do in case you are separated. Reassure them by providing information about how they can get involved.

# **Scam Calls**

Some Talquin Members have experienced scam calls where the caller pretends to be from Talquin Electric Cooperative and threatens to cut off utility services or demands payment over the phone. At times, these scammers have also demanded prepaid credit card payments or stated that Talquin and other utilities are demanding immediate payment. Several Members who have received these types of phone calls were told that they had a balance on their account and needed to pay it immediately or their service would be disconnected. Additionally, scammers can "spoof" Talquin's phone number so that a Member's caller ID displays Talquin's phone number. These phone calls are not authorized or affiliated with Talquin, and unfortunately, we cannot prevent this from happening. However, we want all of our Members to be informed. Do not hesitate to get in touch with Talquin at 850-627-7651 to verify any payment information.

Talquin Electric Cooperative will not call Members and demand immediate payment on a utility bill or make unsolicited calls to schedule energy audits. Please keep in mind that Talquin personnel drive clearly marked vehicles and provide Talquin issued ID, if requested. If you receive a call like this, please report it to Talquin and local law enforcement. Never give your account number, credit card, or bank information to a party that has called you.



# **Backflow Preventers**

Talquin is responsible for implementing a Cross Connection Control Program as required by the Florida Department of Environmental Protection (FDEP) and the Federal Government's 1974 Safe Drinking Water Act. You, as a Talquin Water Member, have the responsibility of having your backflow preventer tested and, if necessary, repaired. Having the backflow preventer tested will reveal any malfunctions or leaks. A leaking backflow preventer will add to your monthly water bill.



Why do we need backflows? Backflow preventers help prevent contaminates from entering your drinking water and protect the public water system from cross-connection generated from water usage beyond the meter.

**Who needs backflows?** FDEP requires all commercial properties and residents with irrigation systems to have backflow preventers installed. The device is commonly located at your property line adjacent to your water meter above the ground.

**How often should they be tested?** Commercial backflow devices are tested every year, and residential backflows are tested every other year by a certified backflow technician.

### WATER APP NOTIFICATIONS

This past February, Talquin unveiled a new feature in our mobile app that will alert Members of any water outages and/or precautionary boil water notices (PBWN) specific to their location. After signing up for notifications, Members will receive a direct notice of any outages or PBWNs that will affect them. Those who have previously elected to receive notifications from Talquin via the app will not need to re-register. Those that have not previously downloaded the app can find it in your device's app store. Simply search "Talquin" and download the app to your phone.

The new alert feature will send notifications to the Member's chosen method: email, text message, and/or push notification. To select which method you prefer, follow these steps:

- 1. Select the "Settings" icon in the app.
- 2. Next, select "Accounts", then select your water account.
- 3. Then, click "Notifications".
- 4. Tap the slider tool to select which methods you would prefer to receive notifications.

Each notification will include a link to receive more information on Talquin's website. In addition to the app, Talquin will continue to use previous notification methods, including door hangers and media notification, as required by law.

# **Planned Outages for Service Improvements**

Ever wonder why your electric co-op intentionally plans power outages?

Talquin Electric continually performs maintenance on the electric system throughout the year to ensure we are providing the best possible service to the Membership. We are able to perform most of this work with the electricity on, so you often do not even notice the work going on around you. However, there are times when we need to interrupt your electric service in order to perform maintenance activities. We call these disruptions in service planned outages.

As you know, electricity is a powerful and dangerous form of energy. Planned outages are sometimes required to ensure the safety of employees, Members, and electrical equipment. We know that outages are inconvenient, but our objective is to be safe while we provide the best service possible to all Talquin Members.

Before a planned outage occurs, we will notify affected Members in advance so they can make preparations. When a planned outage is necessary, our crews will work as quickly and safely as possible to restore electric service with minimal disruption.

#### Tips for Preparing for a Planned Outage:

- If you have medical support equipment that is dependent on electricity, be ready with your backup plan to maintain the use of your equipment.
   Have flashlights with fresh batteries handy.
- Minimize the opening of refrigerator and freezer doors to maintain temperature.
- Shut off or disconnect all sensitive equipment, such as computers, fax machines, televisions, microwaves, etc. before the outage begins.
- Leave a lamp or radio on so you will know when electric service is restored.
- Charge all mobile phones.
- It is very important to turn off any major appliances like washing machines or air

- conditioners prior to the outage. This will prevent them from unexpectedly coming on when the power is restored.
- Double check to make sure all heat-producing appliances (stoves, toaster ovens, irons, and hair curlers) are turned off. This will minimize any fire hazard if the power is restored while you are away.
- Make sure you know how to override or manually operate your security gates or garage doors.
- If you have a generator, be sure to follow all safety guidelines. Please refer to https://www. talquinelectric.com/resources/generator-use/ for more information.

# **Fabulous Fall Recipes**

#### Chicken Pasta Caprese

Adapted from a Skinnytaste recipe, submitted by Member Tina Culbertson

#### Ingredients:

1-pound boneless chicken breast, cut into 1/2 inch cubes (you can also use boneless thighs)
1/2 tsp. dried basil
Salt, per taste
Ground black pepper
Cooking spray
9-oz. dried penne pasta
4 tbsp extra virgin olive oil
6 garlic cloves, coarsely chopped
2 1/2 cups halved grape tomatoes
1/4 cup thinly sliced fresh basil
4-oz. mozzarella cheese cut into cubes



#### **Directions:**

- Heat large non-stick skillet. Season chicken with dried basil, salt and pepper. Spray the skillet with cooking spray and add chicken. Cook until cooked through on both sides, about 5 minutes. Transfer to a plate.
- 2. Cook the pasta according to package directions then drain, reserving 1/2 cup pasta water.
- Meanwhile increase the heat in the skillet and add olive oil and garlic. Do not burn the garlic – keep stirring until slightly soft then add tomatoes and salt and pepper.
   Reduce heat and stir for roughly 8 minutes until tomatoes are soft.
- Add the pasta into the tomato mixture and stir. If it becomes too dry, add some of that saved pasta water. Add chicken and toss well, remove from heat then add fresh basil and cubed cheese.

#### Pumpkin Cannoli

#### Ingredients:

Cooking spray, for pans All-purpose flour, for rolling out dough

15-oz. store-bought refrigerated pie dough

dough
2 tbsp. cinnamon-sugar
2 cups ricotta
1 cup pumpkin puree
1 cup powdered sugar
1/2 tsp. pumpkin spice
1/2 tsp. vanilla

Pinch salt 1 cup mini chocolate chips




#### **Directions:**

- Preheat oven to 350°. Grease 2 nonstick baking sheets with cooking spray. Tear off a large square of foil, and then roll the foil into a long and tight cylinder. Repeat to make 4 cylinders total. Place 2 foil cylinders on each baking sheet and spray foil with cooking spray.
- Onto a lightly floured surface, unroll piecrust and sprinkle all over with cinnamon-sugar. Use a 3" biscuit cutter to stamp out rounds. Wrap the rounds around the foil and pinch together the ends to shape a cannoli shell. Bake until golden and crispy, about 20 minutes. Let cool for 15 minutes before carefully removing from foil
- 3. Meanwhile, in a large bowl, combine ricotta and pumpkin purée and beat until light and fluffy. Add powdered sugar, pumpkin spice, vanilla, and salt and beat until as smooth as possible. Fold in chocolate chips then transfer mixture to a large piping bag.
- 4. Pipe filling into the cannoli shells and serve immediately.


