Whereby Applicant and Cooperative agree as follows:

Applicant applies for membership and agrees to pay the Cooperative membership fee and all applicable fees and charges as required for Cooperative to render requested utility service(s).

Applicant agrees to purchase from Cooperative all utility services requested by this application or otherwise at this or other service locations and agrees to pay for same monthly in accordance with rate schedules, policies, rules and regulations as may be adopted from time to time by Cooperative.

Applicant grants permission for construction, operation and maintenance of all Cooperative utility facilities on the premises and agrees to grant Cooperative a right-of-way easement for same over, under, through and across Applicant's premises. Applicant further grants Cooperative the right to keep all parts of these utility facilities free and clear of vegetative growth.

Applicant grants Cooperative rights of ingress and egress on Applicant's premises so long as any of Cooperative's property remains on said premises in order to perform activities stated above and to read Applicant's meter(s).

Applicant agrees that meter bases must be installed and remain in a location outside of any structure and accessible to the Cooperative for meter readings and route maintenance.

Applicant agrees to cause the premises to be wired in accordance with the National Electric Safety Code, the National Electric Code and all applicable City and County ordinances.

Applicant understands and agrees that electric service may not be initiated or maintained if Applicant's wiring is not installed and kept in compliance with afore-mentioned wiring standards. All similar requirements for other utility services must likewise be met.

Applicant agrees to provide a deposit or suitable guarantee of payment as may be required and that additional deposit(s) or suitable guarantee(s) may be required in the event charges for requested utility service(s) exceed any existing deposit or guarantee. Termination of service for non-payment may require a new deposit or suitable guarantee be provided Cooperative before service is restored.

Applicant understands and agrees that if there is an unpaid balance due on an account for utility service at the service location covered by this application or any service location of Applicant, service may be terminated and such unpaid balance transferred to an active account of Applicant as a due and payable debt of the active account.

Applicant hereby agrees to pay Cooperative's costs of collection for any amounts which become payable to Cooperative but which are not paid when due. Furthermore, the Applicant agrees to pay all costs and expenses of collection, including without limitation attorney's fees, court costs, and collection fees. Collection fees may include, without limitation, the fees of any collection agency, which may be based on a percentage at a maximum of 35% of the debt.

Applicant agrees to pay as a part of the cost of electric service the amount of \$1.00 per year, but not to exceed \$1.50, for the annual subscription of "The Current".

Applicant understands and agrees that a monthly capital credit account maintenance fee will be charged on all capital credit amounts subject to refund which are unclaimed by the Applicant.

Agents signing this application on behalf of principals hereby agree to be jointly and severally liable with their principals under the terms of this application.

Applicant agrees to comply with and be bound by the provisions of this agreement and the by-laws, policies, rules and regulations of Cooperative as may be adopted from time to time by Cooperative. Applicant hereby acknowledges receiving copies of the aforementioned by-laws and Cooperative's rules and regulations.

Acceptance of this application by Cooperative shall constitute an agreement between Applicant and Cooperative from the date service is made available by Cooperative to Applicant and thereafter until canceled by notice given by either party to the other.
