This year was marked by notable achievements and steadfast commitment for Talquin Electric Cooperative. From embracing clean energy solutions to demonstrating unwavering resilience, Talquin showed its dedication to Members. Let's recap the highlights of this eventful year:

Talquin, in collaboration with Seminole Electric Cooperative (Talquin's Generation & Transmission cooperative) and Origis Energy, dedicated three new solar facilities in October. These projects, spanning across Bristol in Liberty County, Hilliardville in Wakulla County, and Hinson in Gadsden County, represent a significant step forward in the pursuit of clean energy. Together, the facilities will generate enough clean energy to power up to 1,400 homes, helping to stabilize fuel rates and minimize fluctuations in the cost of traditional fossil fuels for Members. In August, Hurricane Idalia made landfall, significantly impacting our neighbors to the east while also leaving over 30,000 Talquin Members without power. Despite the challenges brought by the storm, Talquin remained vigilant and prepared. Through the dedicated efforts of Talquin's line crews, office staff, support personnel, and management team, power was restored quickly, emphasizing Talquin's unwavering commitment to Members and

As part of Talquin's commitment to improve Member experience and satisfaction, we recognized the importance of direct interaction with Members, leading to four inaugural "Talk with Talquin – Member Update Events". These events aimed to foster two-way communication between Talquin's Board of Trustees, staff, and Members, while providing timely information and updates on various aspects of the cooperative's operations. Similarly, Talquin's Annual Member Survey represents our commitment for continuous improvement and satisfaction, where feedback from Members is incredibly valuable. Our 2022 Survey saw the highest participation rate in the last five years, signifying Members' interest in the services Talquin provides. The Member satisfaction ratings also reached new highs, with an overall rating of 4.25 out of 5. We're grateful for the positive feedback and will continue to work towards meeting Members' needs. Talquin also continued its tradition of investing in the future by selecting twenty-four high school juniors from Gadsden, Leon, Liberty, and Wakulla Counties to participate in the Talquin Youth Tour. These students not only received scholarships for college or post-secondary education but also had the opportunity to visit Florida's state capitol for an enriching two-day conference. Eighteen of those students received \$500 scholarships for college or post-secondary education. Six student delegates received \$1,000 scholarships but only four were selected to represent Talquin at the National Rural Electric Association's (NRECA) Youth Tour in Washington, D.C. During the National Youth Tour, Eryn Files, a delegate from Talquin, was further selected to represent the entire State of Florida on the NRECA Youth Leadership Council, exemplifying the cooperative's commitment to nurturing young leaders who make a positive impact on their communities and country. ## **CAPITAL CREDITS**

Talquin typically returns capital credits every 15 to 20 years, depending upon the financial condition of the cooperative. This year, Talquin Electric is returning patronage from 2004 and ½ of 2005 account allocations and Talquin Water is returning patronage from 2007, 2008 and 42% of 2011 account allocations. Including this year, Talquin has returned more than \$99,112,832 million in electric patronage and \$2,034,007 million in water and wastewater patronage.

## 2024 TALQUIN YOUTH TOUR & SCHOLARSHIP APPLICATION

## UP TO \$15,000 IN SCHOLARSHIPS TO BE AWARDED!

Talquin Electric Cooperative is looking for students to serve as delegates for the 2024 Talquin Youth Tour. Twenty-four student-representatives will be sponsored with a vist to Florida's captial city for a two-day, overnight conference on February 7-8, 2024 and awarded a scholarship for post-secondary education. Students will learn about the cooperative business model and Florida's legislative process. The Talquin Youth Tour includes a visit to the House of Representatives' Chambers and a session in the Supreme Court. During this experience, four students will be chosen to represent Talquin at the National Rural Electric Cooperative Association Youth Tour in Washington D.C. from June 16-21, 2024. The Washington D.C. Youth Tour includes visits to the Lincoln Memorial, Arlington National Cemetery, Mt. Vernon, Vietnam Memorial, and many more historic sites, alongside hundreds of other students from around that nation!

#### QUALIFICATIONS

- Students must be enrolled as a junior in a local high school or home school;
- Students must have an immediate family member/guardian who is a Talquin Member;
- Students must live in Gadsden, Leon, Liberty, or Wakulla Counties.

#### APPLICATION

Interested students should complete and submit the following:

- 1. Talquin Youth Tour application;
- 250-500 word essay titled, "What makes you a good candidate to represent Talquin on the Youth Tour and what do you expect to gain from this experience?";
- 3. A letter of recommendation from a school counselor, teacher, pastor, community leader, or adminstrator.

#### DEADLINE

Completed application, essay, and letter of recommendation must be received by Talquin no later than **5:00 PM, Friday, December 15, 2023**. Email application to YouthTour@TalquinElectric.com, drop off at a Talquin Member Services Office, or mail to Talquin Electric Cooperative, (Attn: Communications & Outreach, PO Box 1679, Quincy, FL 32353).

#### NOTIFICATION

Students selected for the Talquin Youth Tour will be notified in early January 2024. Washington D.C. Youth Tour representatives will be announced during the Talquin Youth Tour banquet in February 2024.

#### DISBURSEMENT

Scholarship funds are disbursed with verification of post-secondary enrollment after graduating from high school.







## **Talquin Electric Cooperative Dedicates Three Solar Facilities**

Members of Talquin Electric Cooperative are now getting the clean, cost-effective energy benefits from 7 MWAC of solar energy, enough electricity to power approximately 1,400 homes. Officials from the cooperative, along with Seminole Electric Cooperative, Origis Energy and local community leaders dedicated the three new solar facilities this week.

The projects are Hinson Solar, a 4 MWAC project, located in Gadsden County, FL; Hilliardville Solar, a 2 MWAC project, located in Wakulla County; and Bristol Solar, with a capacity rating of 0.63 MWAC, located in Liberty County.

All three projects were developed, constructed and are owned by Origis Energy. Each will deliver clean energy at competitive rates under Power Purchase Agreements (PPAs) executed between Seminole Electric Cooperative, Talquin's wholesale power provider, and Origis.

"These three projects represent a significant step forward and we are excited to provide predictable, affordable, clean electricity to our Members," said Tracy Bensley, General Manager of Talquin Electric Cooperative. "Bringing these projects to fruition will generate enough clean energy to replace fossil fuel-generated electricity for up to 1,400 homes in our area while ensuring stable rates for our Members and shielding them from the fluctuations of traditional fuel costs."

During construction, each plant employed approximately 30 workers with a combined direct local economic benefit of an estimated \$1.6 million. Over the lifetime of the plants, they will generate an additional estimated \$2.2 million in direct economic benefits combined.

"I am proud to be here today on behalf of Seminole to celebrate

Talquin's solar site dedications," said Lisa Johnson, CEO and General Manager of Seminole Electric. "Seminole is excited to support Talquin's initiative to bring more solar energy to its consumer-members."

At each location, native grasses and plants that will provide berries for wildlife were used as part of the vegetative buffer.

"We are pleased to provide affordable, renewable energy to the homes and businesses of Talquin Members," said Josh Teigiser, Managing Director of Distributed Power for Origis Energy. "It's been a pleasure working with both Talquin and Seminole to get these projects energized, and we look forward to providing their Members with reliable, clean power for years to come."

Community leaders reacted favorably to the projects in the area.

## What To Do When a Precautionary Boil Water Notice is Issued for Your Area

When there is a loss in water pressure, due to either a broken water pipe or a scheduled outage for repairs, a Precautionary Boil Water Notice (PBWN) will be issued. A PBWN is issued out of an abundance of caution and not because of known contamination of the water. If the number of affected Members is small, each Member will be informed individually using a printed notice hung on the front door. Members can also receive notifications through the Talquin Mobile App and website.

Water pressure keeps unhealthy pollutants from entering the underground pipes that bring drinking water to your house or business. When the pressure is lost, contaminants could potentially enter the pipes. The loss of pressure might allow pathogens (diseasecausing organisms) into the water that can cause illness if consumed through drinking or food preparation. As a precaution, disinfect tap water to kill any bacteria or viruses that may have entered the water.

Under a PBWN, water used for consumption can be disinfected by any of the following methods:

- Bring the water to a rolling boil and hold it there for one (1) minute.
- If you cannot boil water, such as during a power outage, use a disinfecting chemical. You should put eight (8) drops of common household bleach, which is about 1/8th of a teaspoon, into one (1) gallon of tap water, shake it, and allow it to stand for 30 minutes before drinking. If the water is cloudy, use sixteen (16) drops, about a ¼ teaspoon of bleach instead of 8, shake it, and let it stand for 30 minutes. There should be a slight chlorine odor. Use common household bleach that has 5 to 6% active ingredients. Use food-grade containers. Do not use bleach that has perfume scents added.
- · Using water purification tablets or iodine that many sports and camping stores sell.

These methods are in accordance with the Department of Health's Guidelines, which can be found online at <u>http://www.floridahealth.</u> gov/environmental-health/drinking-water/boil-water-notice-guidance.html.

Consumption includes brushing teeth, washing fruits and vegetables, and making homemade ice. Tap water may be used for showering, bathing, shaving, and washing, so long as care is taken not to swallow or allow water in the eyes, nose, or mouth. Children and disabled individuals should have their baths supervised to ensure water is not ingested. The time spent bathing should be minimized. Though the risk of illness is minimal, individuals who have recent surgical wounds, are immunosuppressed, or have a chronic illness may want to consider using bottled or boiled water for cleansing until the notice is lifted.

Businesses and non-residential sites should take steps such as posting notices or disabling water fountains and ice machines during the PBWN. If you provide water to visitors or employees, use commercially-produced bottled water for drinking or beverage preparation (coffee). Food service operations have additional regulatory requirements.

After the water system is repaired, and the pressure is restored in the pipes to your home or business, the precautionary boil water notice will remain in effect for one to several days while bacteria tests are conducted to assure the safety of the water. The notice will be lifted (rescinded) only after tests prove the water is safe to drink. When a small number of Members are affected, the rescind notice will be delivered similarly to the delivery of the PBWN. All PBWN and rescind notices are posted on the Talquin website (www.TalquinElectric.com), and the Talquin Facebook and Twitter pages.

Talquin takes great care in assuring that your water is safe to drink. We appreciate your cooperation with the Precautionary Boil Water Notice policy, which ensures public health during water outages. Please contact us at (850) 562-2115 during normal business hours if you have questions or concerns. The County Health Department can also assist you with answers to your questions.



## LIGHT OUT? We Need to Know!

If you see an outdoor light that is not working on Talquin Electric Cooperative's system, please contact the Cooperative to report it. When reporting a problem, please provide the information listed below so that we can make repairs and contact you, if necessary.

- Provide the light number located on the pole and describe the location
  clearly. Information such as street name, nearest street intersection, or other landmarks is very helpful. Accurate information is very important in identifying the outdoor light, especially if there are multiple lights in the area.
- Describe the nature of the problem, such as the light blinking, a bulb being burnt out, etc.
- Provide contact information such as the name, address, email address, or phone number of the person reporting the outdoor light so that they can be contacted if needed.

Providing as much information as possible will help ensure the proper response to your request. We certainly appreciate your help in this matter. ## Holiday Appetizers

#### **Traditional Christmas Cheese Ball**

Recipe from allrecipes Love2Cook87 (https://www.allrecipes.com/recipe/155754/traditional-christmas-cheese-ball/)

Total Time: 2 hrs 25 mins / Prep Time: 25 mins / Yield: 12 servings

#### Ingredients:

- 1 ½ (8 ounce) packages cream cheese, softened
- 1 (2.5 ounce) package thinly sliced smoked beef, chopped
- 1 (2.25 ounce) can pimento-stuffed green olives, chopped
- 1 small Vidalia or other sweet onion, minced
- 2 dashes Worcestershire sauce, or to taste
- 1 cup chopped walnuts

#### Instructions:

- 1. Mix the cream cheese, beef, olives, onion, and Worcestershire sauce together in a bowl until evenly blended. Keeping the mixture in the bowl, scrape it into a semi-ball shape. Cover, and refrigerate until firm, at least 2 hours.
- 2. Place a large sheet of waxed paper on a flat surface. Sprinkle with walnuts. Roll the cheese ball in the walnuts until completely covered. Transfer the cheese ball to a serving plate, or rewrap with waxed paper and refrigerate until needed.

#### Ingredients:

- 1 (16 ounce) container sour cream
- 1 cup mayonnaise
- 1/2 (10 ounce) package frozen chopped spinach, thawed and drained
- 1 (4 ounce) can water chestnuts, drained and chopped
- 1 (1.8 ounce) package dry leek soup mix
- 1 (1 pound) loaf round sourdough bread

#### Instructions:

- 1. Mix sour cream, mayonnaise, spinach, water chestnuts, and dry soup mix together in a medium bowl. Chill in the refrigerator 6 hours, or overnight.
- Slice off the top of the sourdough round and pull out the soft interior, leaving a sturdy bread bowl. Fill with spinach mixture. Tear removed bread chunks into pieces for dipping.
