POWER STRUGGLES: FIGHTING FOR RELIABILITY

The American economy and modern societies cannot succeed without reliable electricity. Every part of our society, from transportation to health care, is dependent upon an affordable, reliable electric grid. Smart energy policy recognizes that fundamental truth and works to help keep the lights on. The impact to society of losing the affordability and reliability of our electric grid cannot be debated. Today's society supports eight billion people, and we cannot do that without affordable, reliable electric systems.

On April 25, 2024, the Environmental Protection Agency (EPA) announced final rules to limit greenhouse gas (GHG) emissions from existing coal and new natural gas power plants. While storms create temporary threats to electric systems and cause temporary interruptions, the EPA's new rules will undermine electric reliability and pose grave consequences for our already stressed electric grid, making blackouts and disruptions the norm for our society.

The rules require increasingly stringent carbon dioxide (CO2) emissions controls, such as the implementation of carbon

capture and storage (CCS) to capture and sequester 90% of CO2 emissions by 2032 at coal and new natural gas power plants. Plants that cannot meet the standards would be forced to shut down or curtail their operations.

And herein lies the problem: the EPA's final rules are unachievable and unrealistic. These rules mandate inadequately demonstrated technology, such as CCS. Because the technology is not yet available, the EPA is proposing unachievable emissions limits on unworkable timeframes. Without reliable technology and realistic timeframes, the final rules jeopardize affordable and reliable electricity by forcing the premature closure of always available power plants while also making it harder to permit, site and build critical new power plants.

Also, the EPA's new rules ignore our nation's ongoing electric reliability challenges and is the wrong approach at a critical time in our nation's energy future. These rules were finalized against a backdrop of daunting threats to reliability, as electricity demand surges at the same time supply is decreasing.

The Energy Information Administration (EIA) projects that power demand will reach record highs in 2024 and 2025, increasing by 2.5% and 3.2% respectively. Grid planners forecast electricity demand to grow by 38 gigawatts through 2028, the equivalent of adding another California to the grid. Meanwhile, the North American Electric Reliability Corporation (NERC) has warned that more than 110 gigawatts of always-available generation, enough to power about 35 million homes, will retire through 2033. All or parts of 19 states are at high risk of rolling blackouts during normal peak conditions over the next five years. These new rules will push additional essential always available generating resources off the grid just as the nation is depending on electricity to power more of the U.S. economy.

In short, the final rules will jeopardize reliability and result in more blackouts, higher costs and greater uncertainty for American families and businesses. As the saying goes, when you are in a hole, stop digging – we need to take the shovel away from the EPA.

FLORIDA CO-OPS GO TO WASHINGTON A

In April, leaders from electric cooperatives across the United States came together in Washington, D.C., as they do each year, to advocate for common co-op issues and improving service to Members.

The National Rural Electric Cooperative Association (NRECA) organized the event and led informational sessions preparing coop leaders to discuss federal issues the electrical cooperatives are currently battling. Supply Chain issues, the FEMA Loan Interest Payment Relief Act, and new EPA regulations were key topics discussed.

Co-ops encourage congressional leaders to oppose policies that would lead to higher electricity costs for Members and increase the risk of blackouts. Talquin's leadership is honored to join other Co-op leaders each year and will continue to advocate for our communities on the importance of safe, reliable, and affordable electricity.







THE POWER OF PREPARATION

In April, Talquin conducted Annual Storm Response Training. The training focused on outage management, safety protocols, commuication strategies, and the emergency response plan. We are equipped, now more than ever, to serve and protect our community whatever storms may come. Don't forget to check out the July/August Storm Edition of The Current!

CRITICAL INFRASTRUCTURE PROTECTION

On April 4, 2024, Florida Department of Law Enforcement Commissioner Mark Glass met with leaders from Florida's electric cooperatives to discuss critical infrastructure protection. With attacks on the rise, it's crucial to stay vigilant. Thanks to the passage of HB 275, intentional damage to infrastructure is now a felony. As Commissioner Glass stated, "A good offense is a good defense." Let's work together to keep our communities safe. Report any suspicious activity by calling 1-855-FLA-SAFE. Be in the Know about Backflow!

Talquin is responsible for maintaining a Cross Connection Control Program as required by the Florida Department of Environmental Protection (FDEP) and the Federal Government's 1974 Safe Drinking Water Act. Talquin water service Members are responsible for having your backflow preventer tested and, if necessary, repaired. Backflow testing can reveal malfunctions or leaks. A leaking backflow preventer will add usage to monthly meter readings.

What is Backflow Testing? Backflow testing is a vital procedure aimed at safeguarding the integrity of our water supply system. It involves the inspection and assessment of backflow prevention devices. These devices ensure that water flows in one direction only, preventing any potential contamination from entering clean water supply.



Why is Backflow Testing Necessary? Regular backflow testing helps ensure that our water supply system meets the highest standards of safety and reliability. By identifying and addressing any issues with backflow prevention devices, we can mitigate the risk of contamination and uphold the quality of water delivered to your homes and businesses.

What do Members Need to Know:

- Check the mail! Backflow letters are mailed in April.
- The device is commonly located at your property line adjacent to your water meter above the ground.


